Caregiver Training

The caregiver course is designed for those who want to work in an Assisted Living Facility as a certified caregiver, as mandated by ADHS. Includes complete modules for Supervisory, Personal and Directed care. Open to family caregivers who do not seek certification.

2012 class dates are Tuesday to Friday in Week 1, and Tuesday and Wednesday in Week 2, from 8:30 a.m. to 5:00 p.m., on the following dates:

Manager Training

The Manager course is designed for people who have already completed caregiver training, and wish to become a certified manager of an Assisted Living Facility. In addition to completing this course, you must apply with the Arizona Board of Examiners, comply with their requirements, and pass their exam to become certified. All class dates are 8:30 a.m. to 5:00 p.m. Friday on the following dates:

Manager Exam Preparation Class

This is a fast-paced rules-review course for those preparing to take the Manager Certification Exam with the Arizona Board of Nursing Care Institution of Administrators and Assisted Living Facility Managers. All classes are from 8:30 am – 1:30 pm on the following dates:

Please verify all NCIA exam dates with the NCIA Board directly. The NCIA exam date is usually the first Thursday of each month.

Fee: \$100 – prepay is required – no CEU credit available.

Caregiver Bridge Courses for CNAs, LPNs and RNs

You must have an Arizona nursing license in good standing to enroll in these bridge courses.

CNAs attend days 1, 2, 5 (from 9:00 a.m. – 2:30 p.m.) and day 6 of the regular caregiver course. Cost: \$190.

LPNs and RNs are exempt from all caregiver and manager training requirements. However, we recommend that LPNs and RNs enroll in the Manager course or the Manager Exam Preparation Class to prepare for the state licensing exam. Class days are 1, 2 and 6 of the regular caregiver course. Cost: \$180.

If taking the manager course alone, \$100. If taking with other courses, \$80 – prepay required.

Direct Care Worker (DCW) to Assisted Living Caregiver Bridge Course

This course allows those who have taken the Principles of Caregiving course (or a comparable, verifiable DCW caregiver course) the opportunity to increase their knowledge and to receive an Arizona Certified Caregiver certificate. The course is held on three days, Monday through Wednesday, from 8:30 a.m. to 5:00 p.m. on dates to be determined based upon demand. Continuing Education and Ongoing Training Classes for Assisted Living Caregivers and Managers

FSL provides ongoing education and CEUs at no charge to Adult Foster Care (AFC) sponsors.

Supervisory Care (6 CEUs): Covers elder abuse, resident rights, home and fire safety, infection control, medication assistance, and service planning. All classes are on Wednesdays, 8:30 a.m. – 4:00 p.m. on the following dates:

Fees: \$60 (\$10 per CEU) – prepay required

Personal Care (4 CEUs): Covering purposes and principles of personal care; the aging body; and implications for care. All class dates are Thursdays, 12:30 p.m. – 4:30 p.m.

Pharmacology / Personal Care I / Med-Tech (4 CEUs): Topics include pharmacology & medications management. All class dates Tuesdays, 9:00 a.m. – 4:30 p.m.

Fees for CEUs: \$40 – prepay required. This course is also available as a med-tech certificate course, in which case the fee is \$75, or \$60 for previous FSL caregiving students.
